WARRANTY

Bryan Industries warrants your product to be free from defects in material and workmanship for a period of 12 months from the original date of purchase. All paint work is guaranteed against rusting, flaking and adhesion failure under normal working conditions for 3 months from date of manufacture. If you discover a defect in a product covered by this warranty, we will repair at our option using new or refurbished components, or if repair is not possible, replace the item.

All warranty work will be carried out during normal working hours, i.e. Monday to Friday, 7:30 am to 4:00 pm at Bryan Industries' workshop. All transport and freight costs are to be paid by the customer.

EXCLUSIONS

This warranty covers defects in manufacturing discovered while using the product as recommended by the manufacturer. The warranty does not cover loss or theft, nor does coverage extend to damage caused by misuses, abuse, unauthorised modification, improper storage conditions, lightening or natural disasters. The warranty does not cover parts that are subject to normal wear and tear replacement requirements, such as wheels, buffers and rubber components.

- Electrical wiring and harnesses will not be covered under warranty if tampered in any way including modifications, pressure washing or damage to electrical cabinets. Electrical equipment will be covered under manufacturer's warranty where applicable.
